### **Administrative Updates**





#### **Data Collection Forms and Performance Measures**

- Healthy Start Site Form improved data capture of service area; reduce reporting burden with structured drop-down checkboxes based on service area state(s).
- Updated benchmark data sources and citations as related to the significance of each measure.
- Improved numerator/denominator definitions by creating more standardized terms for use throughout, clarifying items that were sources of confusion, and specifying whether the measure is intended only for participants who were enrolled prior to the intervention being assessed.





#### **HSMED Enhancement**

Enhancement improves error messages in the schema validation step in the HSMED.

- Custom error messages to help better identify and correct common issues.
- Planned rollout: March 9, 2023.





#### **Multi-factor Authentication**

HRSA is implementing "Two-Factor" authentication for the Electronic Handbooks (EHBs), to conform to the Federally mandated Zero Trust Architecture (ZTA).

- All existing Grantee users will have to establish their credentials in Login.gov.
- All prospective users will have to establish their credentials in Login.gov.
- Planned rollout: May 26, 2023.






### **Upcoming Evaluation Activities**

  - Web-based survey for program participants








### # of Participants Served by Year (2018-2021)








# Health Care Access Trends (2020-2021)


# Women's Health Care Utilization Trends (2020-2021)









# Women's Perinatal Health Trends (2020-2021)













# Personal Well-Being Trends (2020-2021)













# Care of Infant/Child Trends (2020-2021)















# **HS Birth Indicators & Infant Mortality Rates** (2021)
